City Ballet, under the direction of Steven Wistrich, presented five productions virtually online since theaters were closed, not allowing audiences to attend performances due to the COVID-19 pandemic. These productions were filmed in an empty theater, then edited and released for online viewing, which were viewed by 2,566 patrons. City Ballet hosted three livestream arts engagements viewed on YouTube by 1,723 patrons. Productions offered virtually included Geoff Gonzalez's premiere of 'The Dark Room Series' of new works, a repertory program titled 'Moving Forward', Elizabeth Wistrich's 'A Masquerade Nutcracker', Geoff Gonzalez's 'Rhapsody in Blue' and Elizabeth Wistrich's 'Raymonda'. Two performances of a 'A Masquerade Nutcracker' were presented live on an outdoor stage as part of the 'Concerts in Your Car Series' to over 3,000 patrons. The arts engagement events included 'Back On Pointe', 'Behind the Mask' and 'Heard it Through the Grapevine'. Total estimated participants for the season was 7,289.

During the COVID-19 pandemic, City Ballet continued to offer education and outreach programs during July 1, 2020 through June 30, 2021: 1) 'Ballet Goes to School' program offered a virtual presentation of a 'A Masquerade Nutcracker' allowing teachers to augment their online arts instruction. This program reached over 450 school children. 2) 'Discover a Dancer' program provided 30 at-risk children with weekly ballet classes during the school year and was offered free of charge via zoom for students enrolled at Kimbrough Elementary and Hardy Elementary. Both are Title 1 schools. 3) In June as venues began to open for live audiences, an outreach performance was offered at the First Presbyterian Church Concert Series in downtown San Diego with 105 attending and another 1000 viewing the live streaming performance. Additionally, an exhibition of 'Rhapsody in Blue' was presented live at The Glen at Scripps Ranch for 70 senior citizens.
